# CALL TO ACTION: Support the Keep Denver Competitive Campaign – Take the survey

Keep Denver Competitive is a broad-based coalition of hundreds of small, family-owned businesses and the state's leading business and employer organizations working together to defeat the vaguely-worded and harmful paid sick leave initiative that singles out Denver and will cost local jobs and stifle economic recovery. The HBA Board of Directors at their August 9<sup>th</sup> meeting passed a resolution in opposition to the initiative and in support of the Keep Denver Competitive campaign.

To help assist the campaign in defeating this measure, we are asking our members who are either located in Denver or who have employees doing work in Denver to take a quick <u>survey</u> to help the campaign gather information on your perceptions of mandated paid sick leave as well as general information on the current business environment in Denver.

As a reminder, the proposed initiative will be on the ballot in November and mandates that employers within the City & County of Denver provide paid sick and safe time leave to all employees (including part-time and temporary employees and, according to legal analysis, employees who work in Denver regardless of the physical location of the business). Employers must provide one-hour of paid sick and safe time leave for every 30 hours worked. Businesses with 10 or more employees must provide up to 9 days (72 hours) of sick and safe time annually. Businesses with fewer than 10 employees must provide up to 5 days (40 hours) of sick and safe time per year. Employees must only work 40 hours per year to be eligible.

#### **Denver Water Updates**

Based on preliminary calculations, Denver Water has issued advanced notice that System Development Charges could increase by as much as 10% for 2012. Denver Water states that the increase incorporates changes in the value of existing assets and the cost of capacity-related projects required to serve new development. The proposed SDCs will be discussed at the 9/14 Denver Water Board meeting, with a vote on adoption no earlier than 10/12. Any changes in would become effective 90 days later. # Arvada Council Discusses Code Adoption, Sprinklers and Radon

At the August 15 Council study session Council staff presented the proposed 2009 code adoption. At their September 12 study session the fire chief will present on the benefits of residential fire sprinklers, even though a proposed code amendment calls for a delayed effective date of January 1, 2013. The fire department is not opposing the delay, but hopes to position council to retain the delayed effective date rather than remove the requirement entirely. Unfortunately the fire chief is misinformed on the cost of sprinklers, which he quoted as less than \$1.00/sqft.

The HBA will be given equal time at the 9/12 study session to present its position on sprinklers. For a copy of the HBA Facility Rental Agreement or for more information contact Toby Paioff at toaioff@hbadenver.com should be aware that only projects in which the infrastructure has not been installed prior to adoption will be required to meet any necessary upgraded water infrastructure requirements. Builders in projects where infrastructure is already in place will likely not be required to install sprinklers. The HBA will confirm this.

On September 8, 8:30 a.m. the Arvada Coordinating Committee will meet with the fire chief for a discussion on fire sprinklers. Arvada builders are encouraged to attend and come prepared to provide facts on costs and other issues related to sprinklers.

Also discussed at the study session was the recommendation by JeffCo Health Department for adoption of IRC Appendix Chapter F, Radon Control. Staff opposes the requirement on the basis that radon detection is an inexact science with variables in testing and results. The HBA concurs with this assessment and opposes mandating radon control as costly and unnecessary. Builders are encouraged to comment.

# Commerce City Ready to Move Forward on 2009 Codes

The 9/26 Council study session will include staff's presentation on the 2009 Codes, including a discussion on fire sprinklers and the new energy conservation provisions.

Staff will seek specific direction from Council before proceeding to ordinance and amendment preparation. The South Adams County Fire Protection District and possibly the South Adams County Water and Sanitation District will also be making presentations to Council. No schedule for 1st and 2nd readings is set at this time.

#### Longmont Continues its "Open for Business" Improvements

At their August 23<sup>rd</sup> meeting Longmont City Council will act on staff's recommendations to both streamline stormwater compliance processes and reduce associated fees. The recommendations will remove unnecessary duplication of State requirements, streamline processes for permit application, permit issuance, site review and construction inspection, and clarify and simplify the requirements for construction and post-construction stormwater pollution control. The recommended reduction or elimination of fees for site plan reviews, permit issuance and inspections reflect these changes.
