#### Castle Rock Utilities Update

The Castle Rock Utilities Department hosted the 11/3 HBA/Castle Rock Contractors Luncheon to hear builders' questions and concerns about the new service line and meter sizing processes, requirements and costs relative to the recent changes.

Among the concerns is that the sizing process currently ONLY allows use of the standard IRC water supply fixture unit and conversion tables, not the use of actual engineered calculations based on the fixtures actually used by builders. These tables, combined with the utility's tap size tables, all but ensure even moderately sized homes will require a ¾" service line and tap, with a high possibility of being forced into a 1" in the case of many typical upgrade options, such as a finished basement with a bathroom or a laundry sink. The HBA and members have been working with Utilities to provide them information that supports our contention that the standard IRC tables significantly over estimate peak demand, as they have not been recently updated to account for changes in industry standards.

### Parker Water and Sanitation District

The inclusion ballot issue failed, so the budget as proposed at the PWSD Board public meeting on Monday October 17 will go to a vote at their November 10 meeting. The budget as proposed includes two new fees to be assessed on new housing: Renewable Water Resource, \$750, and Waste Water Plant Expansion, \$500. The HBA has requested that an analysis of both fees be conducted in the near future to ensure they have a rational and equitable basis and that the HBA participate as a stakeholder in that analysis. The HBA also requested that the implementation of the two new fees be delayed and instituted incrementally, with 50% of each fee being instituted March 2012 and the full fee being instituted July 2012. HBA also suggested that allowing these fees to be collected at time of meter set would provide builders a cash flow flexibility option. Board President Mary Spencer indicated the Board would consider these requests. Staff has indicated they have no problem with the HBA recommendations, but believe the Board will adopt the budget as proposed. If passed, the new fees will go into effect on January 2, 2012. There are no proposed changes to existing fees.

#### Commerce City Prepares to Move Forward with 2009 Codes

Now that fall elections are over, Commerce City Council has scheduled staff to make a presentation on the 2009 codes at their November 28th study session. City staff is prepared to recommend the adoption of the 2009 IRC amended to delete the requirement for residential fire sprinklers. Staff is also proposing a 6 month window for submittal of updated master models under the 2009 editions with a reduced plan review fee of \$150 during this time (new master models will be subject to the regular review fee). Also proposed is a 6 month window for a "soft" transition to 2009 energy code provisions. The effective date for the 2009 editions will be 90 days after 2nd reading and ordinance ratification. The HBA will support staff's recommendations.
