Subject: 2018 Local County and Municipal Fall Election Candidate & Voting Guide

The Metro Housing Coalition ("MHC") Board of Directors met late last month after the candidate vetting process to decide on contributions and endorsements for counties and municipalities in this 2018 fall election cycle. The municipalities and counties were chosen based on an annual tiering process.

Ballots drop 22 days prior to the election. Ballots will be mailed this coming Monday, October 15th with in-person voting beginning October 22, 2018.

Please note that decisions on supported candidates are done through a complete process coupled with weighty analysis.
